INVITATION FOR BID

The Trading Corporation of Pakistan (TCP) is procuring 75,000 M.T sugar from local sugar mills in pursuance of ECC decision. In order to complete survey and inspection of sugar stocks, Trading Corporation of Pakistan (Pvt) Limited, Karachi invites sealed offers from TCP's enlisted surveyors to quote their rates per metric ton for rendering services to carry out survey of sugar to be allocated after purchases from local sugar mills. The functions and responsibilities of surveyor are provided in the Tender Document (terms & conditions) for the tender notice meant for purchase of sugar from local sugar mills. Such functions and responsibilities include the following:-

- a) TCP surveyor will inspect the initially offered sugar of sound and saleable quality of **crop year 2013-2014** as per TCP's specification/requirements given in the Tender Document meant for domestic purchase of sugar.
- b) TCP's Surveyor will require to get the offered sugar tested from PCSIR/ PSQCA Lab., in conformity with the specification given by the PSQCA.
- c) TCP's surveyor will also inspect offered sugar and certify quantity, weight, quality, colour crop year, packing, etc., as per TCP's specifications/ requirements given in the Tender Document meant for domestic purchase of sugar. Such certification(s) of TCP Surveyor shall be final & binding.
- d) TCP's appointed surveyor will be required to ensure that the consignment so inspected is stored in a safe, secured and covered dedicated godowns (provided by the mills). The sealed consignment is then to be handed over to the designated Muqaddams for the purpose of proper security.
- e) The required numbers of samples/packets, for reference purpose, are prepared, sealed and signed jointly with TCP and the sugar mill's representatives.

2. Interested parties may submit their bids, in sealed envelope to be dropped in the tender box placed at the reception counter of TCP's Principal Office, at 4th Floor, Block-B, Finance & Trade Centre, Sharea Faisal, Karachi at **11.00 a.m. on Wednesday, the 26th February, 2014**. The bids received will be opened on the same day at **11.30 a.m.** in the TCP's Board Room in the presence of bidders or their authorized representatives, who may wish to be present.
