### PURCHASE OF 330,000 MT WHITE SUGAR

Trading Corporation of Pakistan (Pvt) Limited, Karachi invites sealed offers from sugar mills in Pakistan for purchase of 330,000 (Three Hundred Thirty Thousand) Metric Tons (MT) White Sugar, packed in polypropylene (PP) woven sacks/bags as per PSQCA approved standards i.e. 1822-2007 (3<sup>rd</sup> Review) and PS 3128-2008 respectively. **However, the sugar mills who defaulted with the TCP are not eligible to participate in the tender unless they clear their dues along with penalties before tender opening date.** Detailed specifications/requirements are indicated in Tender Document containing tender terms & conditions.
