CORRIGENDUM

2. In this regard, certain changes have been made in the tender terms and conditions (para-1 of IFB, tender Clauses No.3(vii), 5(i)(a), 5(i)(d), 7, 18(i), 19(iv), 19(xiii), 19(xxix) and Bid Form Annex-I) which are available on the websites of TCP i.e. www.tcp.gov.pk and PPRA i.e. www.ppra.org.pk.

3. All other terms and conditions, except the changes made in the tender available on the relevant websites mentioned above, shall remain unchanged.

CHANGES IN THE TENDER:

- i) In paragraph No.1 of the Invitation for bids, the words ***“and / or Gwadar Basis”*** have been added after the words ***“on CFR Karachi Basis”***.
- ii) Clause-3(vii) may now be read as under:
“The port of arrival/discharge will be Karachi Port/Port Bin Qasim and / or Gwadar Port as designated by TCP. TCP reserves the right to divert the Vessel to any specific port in Pakistan as per bid/award letter.”
- iii) Clause-5(i)(a) may now be read as under:
“Price shall be quoted in US Dollars PMT CFR Karachi Port/Bin Qasim Port and / or Gwadar Port, as per revised Bid Form (ANNEXURE-I).”
- iv) Clause-5(i)(d) may now be read as under:
“Separate rates to be quoted by the bidder for Karachi Ports (KPT/PQA) and/or Gwadar Port. The discharge port will be subject to clause 3(vii).”
- v) Clause-7 may now be read as under:
“Bids shall be evaluated solely on the basis of offered bid price for Karachi and Gwadar Ports separately, subject to their conformity with terms and conditions of the contract (refer clause-11).”
- vi) In clause-18(i), the words ***“However, for Gwadar Port, at the time of acceptance of vessels, TCP may revise the quantities as per requirements of port parameters.”*** have been added at the end of the clause.
- vii) In Clause-19(iv), the words ***“and/or Gwadar Port”*** have been added after the words ***“ETA Karachi Port/Bin Qasim Port”***.
- viii) In Clause-19(xiii), the words ***“However, for Gwadar Port, at the time of acceptance of vessels, TCP may revise the quantities as per requirements of port parameters.”*** have been added at the end of the clause.
- ix) In Clause-19(xxix), the words ***“and/or Gwadar”*** have been added after the words ***“at Karachi”***.
- x) Bid For has been revised as at **ANNEX-I**.

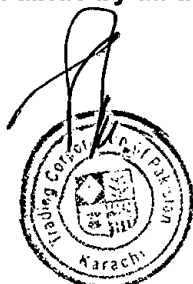
