Reference International Tender of even number appeared in daily Dawn and daily Jang on November 18, 2022.

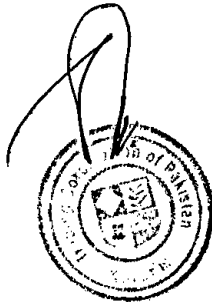

In this regard, certain changes have been made in the tender terms and conditions (Para-1 of IFB, tender clauses No.5(i), 7, 18(i), 19, 19(v), 19(xxi), 19(xxii) and Bid Form Annex-I) which are available on the websites of TCP i.e. www.tcp.gov.pk and PPRA i.e. www.ppra.org.pk. Accordingly, the opening date of the tender has been extended in order to facilitate the potential bidders and the tender shall now be opened on 30th November, 2022.

3. All other terms and conditions, except the changes made in the tender available on the relevant websites mentioned above, shall remain unchanged.

CHANGES IN THE TENDER:

- i) In paragraph No.1 of the Invitation for bids, the words ***“and / or Gwadar basis”*** have been added after the words ***“on CFR Karachi (KPT / PQA) Basis”***.
- ii) Clause-5(i) may now be read as under:
“Price shall be quoted in US Dollars PMT CFR destinations i.e. Karachi Port / Port Bin Qasim basis and / or Gwadar Port basis, as per revised Bid Form (ANNEXURE-I). Afloat Cargo and Containerized Shipment(s) are not allowed.”
- iii) Clause-7 may now be read as under:
“Bids shall be evaluated solely on the basis of offered bid price for Karachi (KPT/PQA) and Gwadar Ports separately, subject to their conformity with terms and conditions of the contract (refer clause-11).”
- iv) In clause-18(i), the words ***“However, for Gwadar Port, only geared vessels are acceptable. At the time of acceptance of vessels at Gwadar, TCP may revise the quantities as per requirements of port parameters.”*** have been added at the end of the clause.
- v) Heading of Clause-19 may now be read as under :
“TERMS OF SHIPMENT ON CFR KARACHI PORT/BIN QASIM PORT AND / OR GWADAR PORT BASIS”.
- vi) In Clause-19(v), the words ***“and/or Gwadar Port”*** have been added after the words ***“ETA Karachi Port/Bin Qasim Port”***.
- vii) In Clause-19(xxi), the words ***“However, for Gwadar Port, only geared vessels are acceptable. At the time of acceptance of vessels at Gwadar, TCP may revise the quantities as per requirements of port parameters.”*** have been added at the end of Clause.
- viii) In clause-19(xxii), the words ***“and / or Gwadar Port basis”*** have been added at the end of clause.
- ix) Bid Form has been revised as at **ANNEX-I**.
